2009 "Why I'm Proud to be a Notary Public" Essay Contest Guidelines and Official Rules

Three winning entries will be chosen:

Essay Contest Eligibility:

a) To enter the 2009 "Why I'm Proud to be a Notary Public" essay content, you MUST be a currently commissioned, United States notary public whose commission term will continue without lapse at least through the month of November 2009.

Submission Guidelines:

- a) Written essay describing, in 250 words or less, "Why I'm Proud to be a Notary Public."
- b) The following contact information must be submitted with your essay: name, mailing address, state where commissioned if different from mailing address, email address, daytime phone. We will utilize your email address to confirm receipt of your essay, or will confirm receipt via telephone or U.S. Mail.
- c) Please retain a copy of your essay for your records; submitted essays will not be returned.

Deadline for Submissions:

a) Essays must be RECEIVED or POSTMARKED no later than October 16, 2009.

Award Notification and Announcement:

a) Winners will be notified by October 26, 2009. Winners will be announced on November 2, 2009.

Disqualification:

Your essay may be disqualified if:

- 1. It is not on the topic.
- 2. You fail to follow any one of the submission guidelines above.
- 3. It is postmarked after the deadline of October 16, 2009.
- 4. It plagiarizes—that is, uses someone else's statements or ideas as your own.
- 5. You do not meet the Contest Eligibility requirements at the time the Essay Contest results are announced or publicized.

- c) ASN will request confirmation of the Essay Contest winners' active notary commission prior to notification or announcement of the winners. An active commission status through the month of November 2009 MUST be confirmed or the essay will be disgualified.
